

Central Virginia FCU Announces the 2025 Joseph P. Crouch Memorial Scholarship

Your Community Credit Union will provide a \$1,000 Scholarship toward tuition or other related fees to a CVFCU member who is a high school senior entering an accredited college or university. This scholarship is based on merit and citizenship of the student rather than financial need.

The applicant must:

- A) Become a member of CVFCU by February 28, 2025
- B) Be a high school senior accepted for admission to an accredited college or university.
- C) Submit the following information to CVFCU by April 30, 2025
 - 1. A completed application form.
 - 2. An official high school transcript.
 - 3. A copy of the letter of acceptance from the school the applicant will be attending.
 - 4. Two letters of recommendation (at least one must be from a teacher, counselor, or other administrator).
 - 5. Submit an essay about: "The importance of community service and why young adults should contribute their time and effort to charitable causes." The essay should be typed and include at least 250 words, but no more than 500 words.

Completed applications and supporting documents must be postmarked by April 30, 2025 and forwarded to:
